

PRESIDENT'S MESSAGE

Medi-Cal is officially insolvent due to a massive spike in costs for illegal immigrant healthcare. **Carl DeMaio** has officially asked President Trump and DOGE to investigate and audit. During a hearing last month DeMaio questioned a state budget official revealing the higher spending figure for Medi-Cal. DeMaio was

state budget official revealing the higher spending figure for Medi-Cal. DeMaio was later removed from the California State Assembly budget committee. It was revealed that California's Medi-Cal had a shortfall of \$6.2 Billion with "unprecedented" cost increases, this is due to people being allowed to qualify for the program regardless of them not having legal immigration status. The state of California underestimated the number of immigrants without legal status. Medi-Cal is funded by state and federal taxpayer dollars.

Democrats in California have suddenly grown quieter on "sanctuary" for illegal immigrants since Trump has begun mass deportations. You might notice that Gavin Newsom has recently started avoiding the word "sanctuary." Newsom has taken on a more muted attitude on immigration... hmmm I wonder why? Possibly because Trump has threatened to prosecute local officials who decline to help our federal authorities with deportations. After our catastrophic wildfires, the possibilities of withholding federal funding from "sanctuary" cities and states have made California much more dependent on federal aid for disaster recovery.

half of the Americans polled wanted to see less immigration to the United States – the first time since 2005 that many of its survey respondents held that view. Most polls show most Americans want immigrants deported if they are convicted of violent crimes. Mindy Romero, founder and director of the Center for Inclusive Democracy at the University of Southern California has stated "The discussion of the day, immediately post the 2024 election, was this focus about Democrats getting it wrong on the economy and on immigration," Romero said … "I think they are hedging their bets by staying quiet on an issue, that they are … seeing how it plays out and the people's reactions to it."

Democrats may be presenting a greatly muted response and recalibrating their message on immigration after seeing a dramatic shift to the right during the presidential election. Some city officials have also stressed that they do not wish to shield criminals from federal law enforcement. It should be noted that California Senate Democrats successfully pressed to designate \$25 million toward legal services for immigrants.


